ORDER

As per Government Order read 2nd above, sanction was accorded to M/s Meenachil Rubberwood Ltd., Kottayam to supply processed rubberwood furniture and office furniture directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. without following tender formalities at

the rate fixed as per Order read 1st above, in relaxation to para 9.23 of the Revised Stores Purchase Manual for a period of one year with effect from 27-4-2019. Now, the Managing Director, M/s Meenachil Rubberwood Ltd. in his letter read 3rd paper above has requested to extend the validity period of above said relaxation for a further period of one more year with effect from 27-4-2020.

2. Government have examined the matter in detail and are pleased to extend the validity period of relaxation of para 9.23 of the Revised Stores Purchase Manual for a further period of one more year with effect from 27-4-2020, so as to enable M/s Meenachil Rubberwood Ltd. to supply processed rubberwood furniture and office furniture directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. subject to the condition that M/s Meenachil Rubberwood Ltd. must strictly follow the recommendations of the inspection report read as 4th paper above and the price of items does not exceed the selling price fixed as per the Government Order read as 1st above. The said relaxation is applicable only for the items manufactured by the institution itself. Manufacturing for the above purpose does not include mere repackaging/rebranding/merely assembly of items.

3. All Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. can purchase their requirements of processed rubberwood furniture and office furniture directly from M/s Meenachil Rubberwood Ltd. without following tender formalities, at the rates not exceeding the selling price fixed as per Government Order read 1st above. They should also ensure that the period of validity of relaxation to para 9.23 of the Stores Purchase Manual is in force at the time of purchase from M/s Meenachil Rubberwood Ltd. and obtain a certificate from the MD of the institution stating that this item has been manufactured by them and not bought from outside.
