ORDER

As per the Government Order read as 1st paper above, Government have permitted M/s. Kerala Soaps, Kozhikode, a unit of Kerala State Industrial Enterprises Ltd to supply soap items directly to all Government departments, Public Sector Undertakings, Local Self Government Institutions without following tender formalities for a period of one year from 28/12/2011 by relaxing the relevant conditions Stores Purchase Manual and accepting the price of soap items fixed by the Price Fixation Committee.

2. Thereafter as per GO read as 2nd paper above, Government revised the prices of soap items and granted permission to public procurement entities to purchase soap directly from Kerala Soaps at revised rates without observing tender formalities for a further period of one year from 19.04.2015. The period of validity was extended for one year each up to 18/4/2018 again.

3. After the expiry of above relaxations, MD KSIE vide letter read as 3rd paper above, approached the Government to revise the rates of the soap items, taking into account the increase in cost of inputs such as cost of raw materials, packing materials, process charges, wages etc. Accordingly, Government constituted a price fixation committee for the purpose vide Government Order read as 4th paper above.

4. The above committee after their discussions unanimously recommended vide 5th paper above to allow the price revision of soap items subject to the following conditions:

- a) The maximum percentage of price increase is to be limited to 25% of over the previous rates approved by Government for the existing soap products.
- b) For new soap products, 11% margin shall be allowed over the cost price.
- c) The price revision is approved by the committee subject to the quality of the soap products, which are really commendable at present.

5. In this circumstances, Government examined the matter in detail and are pleased to accept the price of the soap items fixed by the Price Fixation Committee which is attached to this order as annexure. Hence Government in relaxation to para 9.23 of Stores Purchase Manual order to grant permission to the purchasing officers of Government departments, Public Sector Undertakings, Local Self Government Institutions, Universities and Autonomous Bodies to purchase soap directly from Kerala Soaps at revised rates without observing tender formalities for 1 year from the date of the issue of the Government Order.
