**ORDER**

As per the Government Order read as 1st above, sanction was accorded to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. for direct purchase of wooden furniture from M/s Forest Industries (Travancore) Ltd., Aluva, (FIT) without following tender formalities, by

invoking relaxation to para 57(a) (ii) of Stores Purchase Manual (para 9.23 of Revised Stores Purchase Manual, 2013). Thereafter Government have extended the period of validity of the above said relaxation from time to time and the last extension was granted vide Government Order read 3rd above for a period of one year w.e.f. 27-6-2021.

2. As per the letter read 4th above, the Managing Director, Forest Industries (Travancore) Ltd., (FIT) has requested Government to extend the validity period of the aforesaid relaxation, since the same has expired on 26-6-2022.

3. Government have examined the matter in detail and are pleased to accord tender exemption to M/s Forest Industries (Travancore) Ltd. (FIT), Aluva by relaxing para 9.23 of revised Stores Purchase Manual for a period of one year with effect from the date of issue of this order, or till revision of prices are ordered, whichever is earlier, so as to enable all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. to purchase wooden furniture (Teak Wood, Anjali Wood, Hard Wood) manufactured by M/s Forest Industries (Travancore) Ltd. (FIT), Aluva without observing tender formalities subject to the condition that the selling price of the items should not exceed to that fixed vide Government Order read 2nd above. For items not included in the price list, the other procurement modes as per Stores Purchase Rules shall be resorted to.
