<u>ORDER</u>

Government e-Marketplace (GeM) is an approved mode of procurement for the purchase of commonly used goods and services for public purpose by Government Departments/ Autonomous Bodies/ Public Sector Undertakings/ Local Self Government Institutions/ Universities etc. As per the Government Order read 2 nd above, the procurement of goods and services above Rs.25000/- through GeM is made mandatory for all Government Departments.

2. Vide letter read 3rd above, Chief Executive Officer, GeM informed that faster adoption of GeM by Government buyers was focused initially by onboarding more and more buyers and that caused some incorrect data / mistakes in mapping and some truncated information in the GeM buyer ecosystem. To maintain transparency, accountability and sanctity of data, ensuring of authentication and authorization of GeM buyers is essential. Therefore, as part of new GeM Buyer Registration Processes for a secure authorization framework, CEO, GeM has requested to nominate GeM Registering Authority (GRA) for all the buyers in the State.
