Abstract

Stores Purchase Department - Direct purchase of textile goods from Kerala State Handloom Development Corporation Ltd. (Hanveev) without resorting to tender formalities - Relaxation in para 9.23 of Stores Purchase Manual - sanctioned - orders issued.

ORDER

Sanction was accorded to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. to effect direct purchase of textile goods for their requirement from M/s Hanveev without resorting to tender formalities in relaxation of para 57(a) (i) of Stores Purchase Manual till 31-3-2006 as per the Government Order read as 1st paper above. Later the period of validity of the said relaxation had been extended by Government from time to time and the last extension was done vide Government Order read 2nd paper above.

2) As per letter read 3rd above, the Managing Director, M/s Hanveev has requested Government to extend the period of validity of the aforesaid relaxation w.e.f 15-01-2023 since the same has been expired on 14-01-2023.

3) Government have examined the matter in detail and are pleased to accord sanction to all Government Departments/Public Sector Undertakings/Local Self Government institutions/ Autonomous Bodies etc. to purchase Hanveev Textiles as per their requirement directly from M/s HANVEEV without observing tender formalities, for a period of one year with effect from the date of issuance of this order, by relaxing para 9.23 of the revised Stores Purchase Manual, subject to the following conditions:-

i) HANVEEV must submit the certification guaranteeing the productivity of the firm, ensuring quality alongwith itemwise price of products (which shall not exceed the general market price) selling without following tender formalities with in two months from the date of issue of this Order.

ii) HANVEEV must take seller registration on the GEM portal for the marketing of their products.

iii) Marketing on the basis of this exemption is not allowed after the expiry of the validity period.
